## Travelling with Langley District Homestay Parent - Outside of the Lower Mainland and/or High-Risk Activity Checklist

The following information is included in the application:

- Signatures of Natural Parent, Homestay & School Coordinator
- Student's plane ticket or airline confirmation (if applicable)
- Homestay parent's plane ticket or airline confirmation (if applicable)
- A letter from Natural parents stating that the student can fly/travel out of Canada with the homestay family (if applicable)
- For high-risk activity, a company waiver signed by the natural parent (not permitted for students on guard.me)
- Proof of additional insurance (students on MSP, if travelling out of BC)

The student must take the following on the trip:

- BC Medical Card
- guard.me Card (valid in Canada & US)

In addition, if flying and/or travelling out of Canada the student must take the following valid documents:

- Passport
- Study Permit
- LOA
- a letter from Natural parents stating that the student can fly/travel out of Canada with the homestay family
- Travel visa, if necessary
